Desana will help children and communities thrive by locating key individuals with knowledge of particular needs and utilize that knowledge to put our resources to work doing as much good as possible for as many people as possible for as long as we are able. Our primary programs are as follows:

Uganda

House of Hope- Bulenga: Desana supplies clothing, shoes, educational materials, scholarships, and field trips for 30+ residents.

Naguru Remand Center- Naguru: The organization assists by providing items for 150+ residents including meals, medical supplies, clothing, shoes, hygiene supplies, Bibles, dishes, mattresses, blankets, linens, pesticides, sporting equipment, and firewood for cooking.

Kisenyi Project- Kisenyi: We make regular visits to Kampala's poorest slum and provide wound and injury care, clinic and hospital services for serious injuries and illnesses; clothing, shoes, meals, food items, and hygiene products. Additionally, academic scholarships are given to Kisenyi children every semester so they can attend the local school.

House of Hope- Bujuuko: Construction is currently underway in the House of Hope Village for the first residential home, which will house children from the House of Hope shelter in Bulenga. Additional homes, a church, school, and a clinic will be constructed as funds become available.

Homeless Street Ministry: We provide basic necessities to the indigent living on the streets of Kampala including food, meals, clothing, blankets, hygiene items, and Bibles.

Indigent Scholarship Program: We provide primary and secondary school scholarships to deserving orphans and street children who consistently maintain an average of greater than 80% and exhibit strong moral character.

Russia

Graduate Program- Nizhny Trail: We provide support for children leaving the orphanage system.

Children's Village- Zaimka: We provide a summer BBQ for the children.
